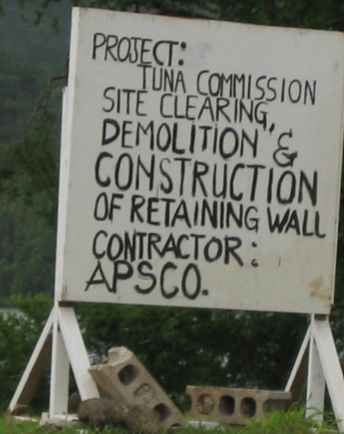

This pivotal agreement stands as the foundation for managing the world's largest tuna fishery, reflecting the joint efforts to conserve and sustainably use highly migratory fish stocks. Throughout these years, the WCPFC has enacted measures to curb overfishing, safeguard vulnerable ecosystems, and bolster the well-being of dependent coastal communities. As we honor this milestone, it's an opportunity to celebrate progress and renew our commitment to overcoming the persistent and new challenges in this crucial ocean region, ensuring its health and the well-being of its communities and stakeholders for future generations.

2024 Interseasonal Work

The Commission commenced its interseasonal activities in January with the FAD-Management Options IWG, led by Jamel James (FSM), distributing a proposed work plan to CCMs and Observers. Efforts progressed in February with New Zealand spearheading a review of the Commission's Seabird measure, alongside Dr. Shelton Harley (NZ) setting expectations for advancing an electronic monitoring program. Further discussions aimed at protecting crew labour rights and safety on fishing vessels continue in 2024, under the joint leadership of Heather Ward (NZ) and Putuh Suadela (ID). Harold Vilia (SB) also resumed discussions of the IWG on the Regional Observer Programme.

WCPFC SECRETARIAT UNDERGOES STRATEGIC RESTRUCTURING

The Secretariat is undergoing restructuring in 2024 to realign its work in a way that reflects the growing priorities of the Commission and the increasing use of technology by members. This reorganization involves transforming the Regional Observer Programme (ROP) Coordinator role into a consultancy focusing on ROP Training and Audits to maintain WCPFC's high standards of training and auditing capabilities.

Karl Staisch (pictured left), who has dedicated years to the ROP Coordinator role, will lead this new consultancy. His extensive experience and profound understanding of ROP standards have been instrumental in their development, including the establishment of the WCPFC's ROP. In his new role, Karl will focus on improving training and audit processes to meet the highest standards of excellence and efficiency. Karl will also continue to support the Commission's interseasonal work on strengthening elements of the ROP.

Working from his home in Brisbane, Australia, Karl's ongoing involvement ensures our commitment to strong and effective ROP practices. This transition not only acknowledges his invaluable contributions but also positions us for continued success in our operational objectives.

In January, the bustling city of Ho Chi Minh, Vietnam, played host to a workshop of the Western Pacific East Asia Integrated Tuna Monitoring Project. This workshop brought together representatives from project countries along with the WCPFC Secretariat and science provider to chart the next phase of the WPEA project. The discussions were aimed at defining priority activities that would drive forward our collective mission in the region. The collaboration set the tone for a year of action and reaffirmed our commitment to sustainable fisheries and the communities they support.

Who are the three WPEA-ITM project countries?

Vietnam, Indonesia, and Philippines

What is the goal of WPEA-ITM? To improve monitoring and management of tuna catches in Indonesia, Philippines, and Vietnam and contribute to reduced Illegal, Unreported and Unregulated (IUU) fishing.

What is the volume of tuna catch in WPEA Project Country fisheries? 28.7% (2021) of total catch of oceanic tunas in the WCPFC Convention Area.

How is the WPEA-ITM project funded? Through a multi-year grant by the Government of New Zealand.



Strategic Global Engagements:

Climate Change and Fisheries Management

Acknowledging the critical impact of climate change on our oceans and the Commission's efforts to incorporate climate change into its discussions, the Secretariat submitted a paper to the 17th Informal Consultations of States Parties (ICSP17) to the UN Fish Stocks Agreement. The paper provides an in-depth analysis of how the WCPFC addresses climate change within its sustainable fisheries management practices, underscoring the Commission's commitment to resilient and adaptive ocean stewardship.

The document outlines a comprehensive framework and ongoing efforts by the WCPFC to address the challenges of climate change on fisheries, emphasizing the importance of scientific research, collaborative international efforts, and the need for adaptive management strategies to safeguard marine ecosystems and the livelihoods dependent on them.

Key points from the paper include:

1. **SEAPODYM Model and Climate Change Research:** The introduction of the SEAPODYM model in 2008 facilitated research into the future abundance and distribution scenarios of key tuna species, considering climate change impacts. This model has been pivotal for stock assessment and understanding climate change effects on tuna populations.

2. **Scientific Committee Discussions and Recommendations:** Through various SC meetings, the WCPFC discussed incorporating ecosystem indicators into management objectives, the application of the SEAPODYM model for spatial management, and the integration of climate change considerations into harvest strategy frameworks and management procedures.

3. **WCPFC Resolutions and Actions:** Resolution 2019-01 on Climate Change was adopted in 2019, committing to consider climate change impacts on fisheries, support further scientific development, and integrate climate change analyses into conservation and management measures.

4. **Assessing and Addressing Climate Change Impacts:** Efforts to assess climate change impacts include the SEAPODYM tool's use for projecting tuna population changes and the initiation of studies to evaluate the vulnerability of Conservation and Management Measures (CMMs) to climate change.

5. **Sustainable Management and Climate Change:** The paper underscores the integration of ecosystem and precautionary approaches, emphasizing the need to account for economic, social, and cultural dimensions in fisheries management amid climate change.

6. **Challenges and Future Directions:** It highlights the importance of collaborative efforts with other organizations, the need for adaptive management strategies, and the focus on developing countries' challenges, suggesting capacity-building measures to support their participation in sustainable fisheries management.

Sustainable fisheries management in the face of climate change requires a multifaceted approach, integrating scientific research, management strategies, and international cooperation to ensure the resilience and sustainability of fisheries and marine ecosystems.

Innovation for Improved Management: Advancing Analytical Tools for Members



Meeting and reporting on the vast range of obligations adopted by the WCPFC is a complex and necessary challenge for Commission members.

To assist in these efforts, the Secretariat is dedicated to the further development of sophisticated analytical tools. These tools are designed to enhance the capacity of CCMs to monitor, report, and ensure compliance, thus strengthening the overall governance of our fisheries. This technology-driven approach represents our investment in a future where sustainability is not just an ideal, but a practical reality.

The Secretariat's Compliance team (pictured above) is learning the necessary skills to ensure it can provide optimal support to members in their efforts to effectively manage and monitor their fishing activities in the Western and Central Pacific Ocean.

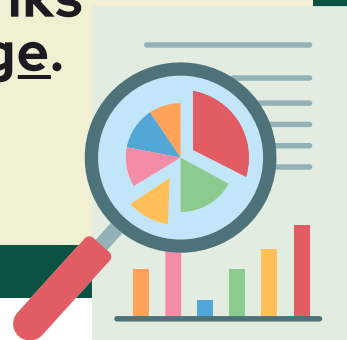

SOUTH PACIFIC ALBACORE

The Western and Central Pacific Fisheries Commission (WCPFC) has made a strategic decision to prioritize the development of harvest strategies for South Pacific albacore in 2024. This initiative is a proactive response to the pressing need for sustainable management practices in the face of environmental and economic challenges affecting this vital fishery.

South Pacific albacore is a key species for many of our member economies and holds significant value for the commercial and artisanal sectors. Ensuring the long-term viability of albacore stocks is paramount to the WCPFC's objectives.

To facilitate this, the Commission has resolved to hold a second science-management dialogue in September 2024, concentrating specifically on South Pacific albacore. The meeting will gather scientific experts and fisheries managers to deliberate on data-driven approaches and to refine the strategies that will govern the harvesting of albacore.

The dialogue aims to establish a comprehensive management framework that aligns with the WCPFC's commitment to maintaining fish stocks at sustainable levels. It is an opportunity to review current research, assess management options, and agree on actionable steps that will lead to robust conservation and management measures.

The Commission recognizes the complexity of implementing effective harvest strategies and is dedicated to engaging in thorough discussions to achieve consensus among stakeholders. The outcomes of the September dialogue will be crucial in shaping the sustainable future of the South Pacific albacore fisheries and supporting the economic wellbeing of our member nations.

As we proceed with these critical initiatives, the WCPFC reaffirms its dedication to science-based management and the sustainable use of marine resources for the benefit of current and future generations.
