**Full draft Compliance Monitoring Report covering 2015 Activities Available for CCMs**

Dear All,

To advise that in accordance with CMM 2015-07, *Conservation and Management Measure for Compliance Monitoring Scheme* paragraph 26 CCMs have access to the full draft Compliance Monitoring Report (draft CMR) online at <https://intra.wcpfc.int>.

Authorised CCM users can use their usual CCM-CMR user name and password to access the online full draft CMR report.

*CCM replies to draft CMR including additional information (CMM 2015-07 para 24)*

The Secretariat has reviewed the additional information provided in CCM replies, and has updated the “Potential Issue”, “Secretariat Explanation” and “CCM additional information” columns within the full draft CMR. The full draft CMR includes CCM replies and notes on any additional information received by WCPFC as at 6 September 2016. The full draft CMR also confirms when additional information was provided in CCM replies in response to “capacity development plans” and “investigation status reports”.

*Capacity Development Plans (CMM 2015-07 paras 5 – 7)*

A copy of information provided by CCMs related to Capacity Development Plans received by WCPFC as at 6 September 2016 will be posted to the CCM side of the WCPFC website shortly (<https://www.wcpfc.int/cmr-2016>).

*Investigation Status Report (CMM 2015-07 paras 8 – 11)*

Detailed information provided in CCM replies related to Investigation Status Report have been included as notes in the individual case files within the online Compliance Case file system.

Summary notes based on the online Compliance Case file system have been included in the full draft CMR.

CCMs are encouraged to continue to use the online Compliance Case file system to submit reports on investigation up until the conclusion of the investigation and where applicable, any relevant Investigation Status Reports can also be attached (CMM 2015-07 para 8-11). CCMs are asked to refer to Circular 2016/14 and Circular 2016/42 for guidance on how to access and provide updates.

*Other additional information of further CCM replies to draft CMR (CMM 2015-07 para 27)*

In accordance with paragraph 27 of CMM 2015-07, copies of any other additional information that CCMs may provide will be posted to the CMR-2016 page on the CCM side of the WCPFC website ( <https://www.wcpfc.int/cmr-2016> ). The individual CCM portal pages will continue to be available, and as appropriate will be used by the Secretariat to provide CCMs with updated supporting documentation relevant to their individual draft CMR potential issues.

With the full draft CMR now complete, the Secretariat has closed-off CCM write-access to the “Potential CMR issues” online reply system.
