## FULL DRAFT COMPLIANCE MONITORING REPORT COVERING 2013 ACTIVITIES AVAILABLE FOR CCMS

Dear All,

To advise that in accordance with CMM 2013-02 paragraph 13, CCMs have access to the full draft Compliance Monitoring Report (draft CMR) online at <a href="https://intra.wcpfc.int">https://intra.wcpfc.int</a> . CCMs can use their usual individual CCM-CMR user name and password to access the online full draft CMR.

CCM replies to draft CMR including additional information (CMM 2013-02 paras 12 and 14)

The Secretariat has reviewed the additional information provided in CCM replies, and has updated the "Potential Issue", "Secretariat Explanation" and "CCM additional information" columns within the full draft CMR. The full draft CMR includes CCM replies and notes on any additional information received by WCPFC as at 31 August 2014.

In accordance with paragraph 14 of CMM 2013-02, copies of any other additional information that CCMs may provide will be posted to the CMR-2014 page on the CCM side of the WCPFC website (<a href="https://www.wcpfc.int/CMR-2014">https://www.wcpfc.int/CMR-2014</a> ). The individual CCM portal pages will continue to be available, and as appropriate will be used by the Secretariat to provide CCMs with updated supporting documentation relevant to their individual draft CMR potential issues.

With the full draft CMR now complete, the Secretariat has closed-off CCM write-access to the "Potential CMR issues" online reply system. Copies of any other additional information from CCMs relevant to draft CMRs should be sent to Lara (<a href="lara.manarangi-trott@wcpfc.int">lara.manarangi-trott@wcpfc.int</a>) and 'Ana (ana.taholo@wcpfc.int), with a copy to contact.ar@wcpfc.int.

To assist CCMs with their reviews of draft CMRs and preparations for TCC, the Secretariat will post to the CCM side of the WCPFC website ( <a href="https://www.wcpfc.int/CMR-2014">https://www.wcpfc.int/CMR-2014</a>) three (3) sets of additional summary documentation for full draft CMRs. These are:

- A MS Excel copy of the full draft CMR with some explanatory notes on the dCMR template;
- Two "traffic light" summaries of the full draft CMR (by CMM and by draft CMR section); and
- Summaries of full draft CMR with a section for each CCM, and any replies on actions in response to previous year compliance issues.

## Reminder on outstanding Annual Report Part 2

Access to the online Annual Report Part 2 reporting system remains enabled for the remaining CCMs who are yet to submit their report covering 2013 activities. We encourage the few CCMs with outstanding Annual Report Part 2 to consider completing their report in advance of TCC10 so that they can be considered received. For those CCMs who are interested in reviewing other CCMs AR Pt 2 reports, a MS Excel copy of all CCMs AR Pt 2 reports covering 2013 activities is currently posted to the CCM page of the website: https://www.wcpfc.int/annual-report-part-2-2014.
