In this opportunity, the Republic of Panama through the Aquatic Resources Authority of Panama (ARAP), as the national entity responsible for the protection, conservation and management of the aquatic resources, commits itself to the fulfillment of its international obligations related to the regulation, management and control of the aquatic resources. Moreover, for our Administration, it becomes critical to prevent, deter and eliminate illegal, unreported and unregulated (IUU) fishing.

For this reason, we wish to collaborate on an ongoing basis as a cooperating Party, complying with the measures of management, conservation and protection of the Western and Central Pacific Fisheries Commission (WCPFC), as well as sharing the information it holds related to Panamanian-flagged vessels operating in the area of competition under its direction.

Likewise, Panama shares information and documentation that has become known to it about vessels under the Panamanian registry involved in illegal fishing, unreported and unregulated fishing.

Pursuant to this commitment, the Government of Panama adopted regulations aimed at the management and control of the aquatic resources properly.

Therefore, and based on the preceding paragraphs, we make *formal application* to *renew the status of Cooperating non Member to the Western and Central Pacific Fisheries Commission (WCPFC)*, with the objective that the vessels of Panamanian Registry have access related in support fishing vessels and fishing vessels who operate in that region of the world.
