The Conservation and Management Measure on Cooperating Non-Members (CMM 2009-11) requires the Executive Director to forward a copy of the relevant TCC recommendations and advice to applicants for Cooperating Non-Member (CNM) status following the recent annual meeting of the Technical and Compliance Committee (TCC14).

*Cooperating Non-Member Requests*

TCC14 in considering the applications for CNM status in 2018 reached the following decisions and recommendations:

- (a) agreed to forward your country's application to WCPFC15 for consideration;
- (b) noted with appreciation El Salvador, Liberia, Thailand and Vietnam attendance at this year's meeting and encouraged other CNM applicants to attend TCC meetings in the future;
- (c) noted that all CNM applicants other than Mexico and Vietnam have made financial contribution in 2018 and also noted Vietnam's statement that payment is in progress;
- (d) noted that Ecuador, Mexico, Thailand, Panama, Vietnam, and El Salvador have reiterated interest in becoming full Commission members;
- (e) noted the following gaps or issues in your countries application:

**a. Vietnam** – TCC14 noted that Vietnam's CNM application was submitted late, but that Vietnam's Part 1 and Part 2 Reports have been received by the WCPFC and Vietnam complied with the submission of 2017 scientific data to the Commission.

- (f) recommended that this letter and any responses from your country should be assessed by WCPFC15; and
- (g) recommended that WCPFC15 take into consideration the Compliance Status of all CNM applicants in making its decision on the CNM applications and participatory rights.

Please find attached to this letter for your review and consideration prior to WCPFC15 Attachment 1 which include relevant advice and recommendations from the draft summary report of TCC14 on CNM applications.

## Attachment 1: Excerpt from TCC14 DRAFT SUMMARY REPORT

### AGENDA ITEM 4— CNM REQUESTS

1. In accordance with CMM 2009-11, TCC13 considered the applications for Cooperating Non-Member status for 2018, as summarised in **WCPFC-TCC14-2018-07**, and established the CNM SWG (led by Nauru) to develop draft recommendations and technical advice for the consideration of the Commission. The WCPFC Compliance Manager stated that the Secretariat had received 8 requests for CNM Status in 2019, from Ecuador, El Salvador, Liberia, Mexico, Nicaragua, Panama, Thailand and Vietnam. Table 1 of TCC14-2018-07 details the dates and formats of the requests; the Compliance Manager noted that use of the correct format by CNMs was helpful to the Secretariat when processing the requests. Table 2 of TCC14-2018-07 summarizes financial contributions by CNMs as of 8 August.

2. On 27 September 2018 the CNM Small Working Group (SWG) led by Nauru (Mr Ace Capelle) reviewed CNM applications and reported back to TCC14 providing relevant recommendations.

3. TCC14 has reviewed the following CNM applications and is forwarding them to WCPFC15 for consideration: **Ecuador, El Salvador, Liberia, Mexico, Panama, Nicaragua, Thailand and Vietnam.**

4. TCC14 noted with appreciation the attendance and participation of El Salvador, Liberia, Thailand and Vietnam at this year's meeting and encouraged other CNM applicants to attend TCC meetings in the future.

5. TCC14 noted the CNM working group process had occurred in parallel with the compliance monitoring scheme process and recommended that following TCC14, in consultation with SPC, the Secretariat write a particularised letter to CNMs outlining any identified deficiencies in data provision and request that CNM applicants provide any information outlined in these letters, as requested during the CMS process, 30 days in advance of WCPFC15, and that these letters and any responses be assessed by WCPFC15.

6. TCC14 recommended that WCPFC15 take into consideration the compliance status of all CNM applicants in making its decision on the CNM applications and participatory rights.

7. TCC14 noted that all current CNMs seeking to renew CNM status other than Mexico and Vietnam have made financial contributions for 2018 and noted Vietnam's statement that payment is in progress. The WCPFC has received Ecuador's financial contribution although it is not stated in Table 2 of WCPFC-TCC14-2018-07.

8. TCC14 noted that Ecuador, Mexico, Thailand, Panama, Vietnam, and El Salvador have reiterated interest in becoming full Commission members.

9. TCC14 noted the following gaps or issues in the applications for individual applicants and encourages applicants to rectify them if possible by WCPFC15:

10. **Ecuador** – Although Ecuador has paid its 2018 financial contribution it wasn't represented at TCC14.

11. **El Salvador** – TCC14 noted that El Salvador submitted both its Part 1 and Part 2 Report after the deadline, but that El Salvador complied with the submission of 2017 scientific data to the Commission.
12. **Liberia** – TCC14 noted that Liberia failed to meet the deadline in submitting its Part 2 Report in time.
13. **Mexico** – TCC14 noted that Mexico has still not made an explicit commitment to accept High Seas Boardings and Inspections and that Mexico considers this requirement as not applicable since it does not have any vessels in the Convention Area. TCC14 noted that Mexico had not paid its 2018 financial contribution.
14. **Nicaragua** – TCC14 was not in a position to discuss compliance issues with Nicaragua's application, as it has not previously been granted CNM status, and deferred consideration of the application to the Commission.
15. **Panama** – TCC14 noted, based on updates from the Secretariat, that Panama submitted its Part 1 and Part 2 Reports on time but that there were reporting gaps that could require clarification. Some CCMs also noted that Panama is consistently non-compliant in the South Pacific Regional Fisheries Management Organisation for serious violations of obligations and is on warning in that forum.
16. **Thailand** – TCC14 noted that Thailand may not have provided full historical data on fisheries activities in the Convention Area pursuant to CMM 2009-11 (2)(d). An applicant for CNM status is required to include in its requests full data on its historical fisheries in the Convention Area, including nominal catches, number/type of vessels, name of fishing vessels, fishing effort and fishing areas, pursuant to CMM 2009- 11(2)(d). Thailand expressed doubt its flagged vessels have fished in the Convention Area.
17. **Vietnam** – TCC14 noted that Vietnam's CNM application was submitted late, but that Vietnam's Part 1 and Part 2 Reports have been received by the WCPFC and Vietnam complied with the submission of 2017 scientific data to the Commission.

# **2018 PROVISIONAL COMPLIANCE MONITORING REPORT (COVERING 2017 ACTIVITIES)**

## **Executive Summary**

### **I. INTRODUCTION**

1. TCC14 undertook its eighth annual review of compliance by CCMs against an updated priority list of Commission obligations agreed to at WCPFC14 for 2018.
2. TCC14 conducted its review in accordance with the extended Compliance Monitoring Scheme (CMS) adopted at WCPFC14 – CMM 2017-07.
3. Consistent with recent versions of the CMS, the current CMS does not require an overall assessment of each CCM, but only asks TCC to identify a compliance assessment for each specific obligation.
4. In accordance with Annex I of the CMS CMM, the following statuses were considered in making the assessments: Compliant, Non-Compliant, Priority Non-Compliant, Capacity Assistance Needed, Flag State Investigation and CMM Review.

### **II. DEVELOPMENT OF THE PROVISIONAL COMPLIANCE MONITORING REPORT BY TCC14**

5. TCC14 reviewed the draft Compliance Monitoring Report (draft CMR) for thirty-seven (37) CCMs and one (1) collective group of Members in a closed working group session. The draft CMR is classified as non-public domain data and some CCMs were not able to agree to release their non-public domain data, therefore the decision was made to close the session. There continues to be interest among some CCMs and Observers (who were not able to attend the closed session) in finding a way to address the confidentiality concerns of CCMs so that Observers can more fully and effectively participate in the CMS. It was noted that this should be part of the discussion on the revised CMS CMM.
6. TCC14 notes that the Provisional CMR provides its provisional compliance assessment and it is submitting this report to the Commission for its consideration and final assessment.

### **III. COMPLIANCE REVIEW PROCESS AND ASSESSMENTS**

7. TCC14 agreed to a CMR Review Process in advance of conducting its review (WCPFC-TCC14-2018-09).
8. Consistent with our practice last year, TCC14 received reports from CCMs on the progress of capacity development plans and flag state investigations. The outcomes of both discussions are in the tables below.

9. TCC14 noted that although there has been improvement in the ability of flag CCMs to obtain observer reports relevant to investigate alleged violations, there is clear need for improvement both in the way that some flag CCMs request information and the response from some observer providers, so that flag CCMs can complete investigations. TCC14 urged flag CCMs and ROP observer providers to engage while here at TCC and in the margins of other meetings to facilitate the provision of observer reports.

10. TCC14 noted that the practice of limiting verbal interventions to clarifications was useful in streamlining the CMS process at TCC, but may result in more assessments needing to be done at the Commission meeting.

11. In accordance with paragraph 29 of CMM 2017-07, where there were majority/minority views on the correct assessment, TCC14 took the assessment of the majority view and noted the minority view. TCC14 notes the following assessments with majority/minority views for the

Commission for its final assessment:

a. CMM 2005-03, para 2 – The majority view was that Korea should be assessed as priority non-compliant; however, there were two minority views. One was that Korea should be assessed as compliant and one that the measure was not applicable to Korea.

b. CMM 2010-07, para 9 – The majority view was that Korea should be assessed as flag state investigation; however, there was a minority view that Korea should be assessed as compliant.

c. CMM 2013-08, para 1 – The majority view was that Korea should be assessed as flag state investigation; however, there was a minority view that Korea should be assessed as compliant.

d. CMM 2016-04, para 3(2) – The majority view was that Japan should be assessed as compliant; however, there was a minority view that no assessment could be made.

12. There were some obligations that TCC14 assessed as CMM Review. TCC14 noted that in some cases, such as in relation to CMM 2016-01, the obligations in question have already been revised in CMM 2017-01, but encourages the Commission to consider whether additional revision is needed to resolve the difficulties in assessment. TCC14 notes the following obligations were assessed as CMM Review:

a. CMM 2014-02, para 4

b. CMM 2016-01, paras 14, 16 and 18

13. There was one obligation that TCC14 was not able to assess, because there were no clear majority or minority views. TCC14 notes the following issue for the Commission to consider in its final assessment:

a. CMM 2016-01, para 22 – TCC14 could not take an assessment for the Philippines against this obligation, because there was not clear understanding of the obligation or whether the Philippines had met it.

14. As noted in the paper on the CMR Review Process, WCPFC-TCC14-2018-09, there were a number of alleged violations from 2015 and 2016 that were not included in last year's CMS because the information came in after the CMS was completed. TCC14 reviewed the outstanding alleged violations from 2015 and 2016. The table below reflects the status of that review.

15. As noted in the paper outlining the TCC CMR process (WCPFC-TCC14-2018-09), and consistent with the recommendation from TCC13 and the decision from WCPFC14, TCC14 did not consider the information contained in the ROP Pre-notification List for the purpose of assessing any obligations for which it was relevant.

16. Consistent with the Final Compliance Monitoring Reports from 2012 – 2017, CCMs evaluated as “non-compliant” for obligations are strongly encouraged to address their implementation issues even without a response procedure.

#### IV. ISSUES RELATED TO SPECIFIC CMMs OR OTHER OBLIGATIONS

17. The European Union expressed concerns over the process on reporting back on ongoing Flag State Investigations and suggested that criteria should be developed for this process. The PNA noted that they would like to eliminate the entire Flag State Investigation process.

18. Canada and China noted that CMM 2005-03 (North Pacific Albacore), paragraph 3, will be considered at NC15 in 2019 to change reporting from every 6 months to annually for all CCMs. The proposed revision will bring the CMM’s reporting requirement into alignment with the recently revised IATTC resolution on the same issue. The proposed revision is advanced in the absence of any apparent scientific benefit for 6-month reporting.

19. TCC14 noted with concern that despite some improvement some CCMs still do not comply with the requirement under CMM 2007-01 Attachment K Annex C paragraph 6 (minimum 5% ROP longline coverage rate).

20. There was a discussion about whether a WCPFC14 decision regarding reports against CMM 2009-06 (transshipment), paragraph 13 was binding. The Legal Advisor noted that decisions of the Commission could be binding (if the language so indicated), but that the WCPFC decision regarding reports against paragraph 13 of CMM 2009-06 was not included in the items against which CCMs would be assessed this year. **TCC14 recommends to WCPFC15 that the Commission agree that TCC’s assessment of a CCM under paragraph 13 of CMM 2009-06 will include that CCM’s report on observer coverage achieved for their carrier vessels conducting transshipment at sea in their Annual Report Part 2.**

21. The European Union expressed concern that TCC was not assessing paragraph 7 of CMM 2010-07 (Sharks) in conjunction with paragraph 9 of the same CMM, and requested that this is included in the future assessments of this measure.

22. For CMM 2011-04 (Oceanic Whitetip Sharks), FFA members raised a concern about its members being assessed for data inconsistencies with numbers that had been revised since the submission of its members Annual Reports. FFA members noted that CCMs should be assessed as compliant where they have provided all available data at the time of submission, even if new data comes in later.

23. The United States and the European Union expressed concern that we were not assessing paragraph 1 of CMM 2011-04 and noted it should be included in future assessments of this measure.

24. Paragraph 4 of CMM 2014-02 (Vessel Monitoring System) was deemed CMM Review, but Japan and the United States thought that this paragraph may be obsolete and suggests the Commission consider revising this measure to remove or revise this paragraph.

25. TCC14 noted that unlike last year, this year TCC14 was able to take assessments against CMM 2014-02, paragraphs 9a and SSPs 2.8. TCC14 noted that in 2017 and 2018, the Secretariat was making improvements to the VMS and that while these improvements are in process, assessments remain challenging.

26. The United States highlighted the importance of CMM 2015-02 (South Pacific Albacore) and noted the need for a rigorous and more meaningful review of this measure in future years, and that WCPFC-TCC14-2018-IP14 reveals a dramatic increase in the number of fishing vessels of certain CCMs actively fishing for South Pacific albacore south of 20S since the measure was first adopted in 2005. Australia and New Zealand noted that the paper WCPFC-TCC14-2018-IP14 from SPC on South Pacific Albacore is very informative and is the kind of information they would like to see every year, as it shows that we are clearly not yet hitting the mark with this measure.

27. As noted in paragraph 12 above, paragraphs 14, 16 and 18 of CMM 2016-01 were deemed CMM Review. CCMs noted that these paragraphs have been revised in CMM 2017-01, but encourages the Commission to review these paragraphs in any revised measure to ensure they are more easily able to be assessed in the future. CCMs also noted that our inability to assess these paragraphs impacts our ability to evaluate the effectiveness of this measure.

28. China noted the need for increased clarity relating to charters in relation to CMM 2016-01 and subsequent versions of this measure.

## **V. REQUESTS FOR ASSISTANCE AND CAPACITY BUILDING**

27. Several areas were identified where targeted assistance is required to assist SIDS and other CCMs in implementing specific obligations.
